horrifying.

MATCH CUT TO:

INT. HOSPITAL ROOM - NIGHT

De'Jaun grips his mothers hand hard with pain and love. He  
sits by her side... she is sick. Near the end.

Sometimes, justice must be rescued  
by something much deeper... Namely  
love.

CUT TO BLACK

TITLES OVER BLACK:

Over one million signed petitions where submitted to the  
Georgia Board of Pardons calling for a stay in the Execution  
of Troy Anthony Davis.

Outspoken critics of Troy's execution included jurors from  
his original trial, the former warden of the Georgia State  
Prison where Troy was housed, President Jimmy Carter, Desmond  
Tutu, and Pope Benedict XVI.

Two months after the execution of her brother, Martina Davis-  
Correa lost her battle with breast cancer.

She is survived by her son De'Jaun, the first member of the  
Davis family to attend college.
